As a result of passage of the "Budget Bill", the Ohio Division of Securities became a "rotary" agency. In short, this means that funding levels for the Division will be determined by the income of the agency, rather than by legislative appropriation.

Almost all the fees and charges contained within Chapter 1707 of the Revised Code were increased effective July 30, 1979.

The following table sets forth the type of filing, Revised Code Section number, the old fee and the new fee. The Division of Securities will publish new forms which will reflect these fee increases as soon as possible. It should be noted that the fees for filings under Section 1707.03(O) and 1707.03(Q) of the Revised Code were not changed and remain at twenty-five dollars.
